## Policy declaration for Safety, Health, Environment and Quality

We want to build **a long-term relationship with our clients** by having **constant attention for safety, health, environment, quality and ethics**.

Safety, health, environment, quality, ethics, efficiency, continuity and profitability get equal attention while determining and achieving company objectives. The safety and health of our employees and others are always our priority.

We are constantly looking to improve our performance in all fields of sustainable development, particularly on lowering our CO2 impact (scope 1 and 2), to ensure that as a solid company we can consolidate and improve our position in the market. - **To react immediately** upon discovery of **unsafe or unhealthy situations or environmental risks**, as well as anomalies and to report these to their supervisor.

To fulfil these obligations our **employees** are **sufficiently informed** about **and trained** in safe and environmentally friendly practices, prevention of accidents and environmental pollution, emergency procedures and ethical principles.

To support this policy **SPIE Belgium fixes annual objectives** and **follows up their progress**, both on the company level and within all business units and departments. Senior management reviews the efficacy of the management system at least once a year.

The management team of SPIE Belgium is convinced it is possible to achieve the required quality, to prevent injuries as well as damage to goods and the environment (and thus financial damage) by applying a structured policy tailored to these goals. It has committed to continually optimise the management system to improve its performance.
